

## Price List of Services of the Statistical Office of the Slovak Republic

Last update: 10.03.2023

The prices of outputs from the processing of Statistical Office of the Slovak Republic are uniform for all users. The users are notified in advance about the total costs calculation in case of each paid request, except of enumeratively determined price calculation. The employees of workplaces of Information Services ensure the processing of requests, only after the approval of prices by the users. The protection of confidential statistical data is consistently respected in the processing of all requests. Consultations on methodical issues and consultations on data access (including data from external sources) and the possibilities of their provision are offered free of charge.

### 1. NON-STANDARD OUTPUTS

Non-standard output is any output that results from the processing of data in a specialized department of the Statistical Office of the SR.

#### 1.1 Outputs, based on individual processing

Price calculation of non-standard outputs at user's request includes costs measured by consumption of working time needed for:

- evaluation of a request in terms of feasibility
- determination of data sources of which information is processed
- data processing
- verification of data correctness

Payment for processing of outputs is charged for one hour of work of professional employee, **18,40 EUR**. The total fee shall be set according to actual consumption of working time approved by a processor or processors, if the request processing is carried out at several specialized workplaces of the Statistical Office of the SR.

#### 1.2 Retrievals from the internal databases of the Statistical Office of the SR

##### 1.2.1 Database of foreign trade statistics

The database contains data on imports and exports of goods broken down by CN (Combined Nomenclature) or HS (Harmonized System), SITC (Standard International Trade Classification), BEC (Broad Economic Categories), CPA (Statistical Classification of Products by Activity) since 2010. Data are divided by country and by country grouping. Data are available for monthly, quarterly or annual periods. Data are provided in value (EUR), weight (kg) and quantity (according to the relevant additional unit of measurement).

A fee of **18,40 EUR** per hour of work of a professional employee is charged for processing of outputs. In the case of a large working time consumption, the price is determined by agreement

## 1.2.2 Register of Organizations and Register of Accommodation Establishments of the SR

Excerpts of data from the Register of Organizations for the Slovak Republic are provided by [Infostat](#) and the data by region by the Regional Offices of the Statistical Office of the SR. Data from the Register of Accommodation Establishments of the SR are provided by the Regional Office of the Statistical Office of the SR in Prešov. Excerpts are performed on the basis of written orders.
