

The yearbook is again available in electronic format, in full range and free of charge from the moment of publication.

The new electronic version of the publication make it possible to increase the number of editions of the yearbook, to publish its content in several time stages according to the availability of data from various sources. **The Statistical Yearbook of the Slovak Republic 2023 has two editions. The second edition published on January 22, 2024 extended the content of the tables in the chapters 7. Health, 13. Fixed Assets and 18. Energy.**
