| 3.1 Data description   |   |
| <p>The data provide users with information about protected areas in Slovakia. They provide an overview of the number and size of protected areas by type (national parks, protected landscape areas (PLAs), nature reserves, national nature reserves, natural monuments, national natural monuments, protected sites, protected landscape elements and special protection areas (SPAs). <i>Note: Specially protected parts of nature and landscape also include sites of Community importance (SCI) , areas of international importance, private protected areas as well as protected trees and protective zones of the protected areas and protected trees. These areas/features are not included in categories of protected areas under § 17 of Act No. 543/2002 Coll. on Nature and Landscape Protection, as amended (though SCIs are considered as protected areas within procedures under the relevant acts) and so were not recorded in the overviews for Statistical Office of the Slovak Republic. During the amendment of the cited Act (Act No. 506/2013 Coll.), a new category was added - municipal protected area, which has not yet been included in the data of the Statistical Office of the Slovak Republic.</i></p> |   |

### 3.4 Statistical concepts and definitions

A protected area is a geographically defined territory that is designated, regulated and managed with the intent to achieve specific conservation objectives. These are sites with habitats of the Community and national interest, habitats of species of the Community and national interest, habitats of birds, including migratory species, important landscape elements or natural features. Categories of protected areas are: PLAs, national parks, nature reserves, national nature reserves, nature monuments, national nature monuments, protected sites, protected landscape elements and SPAs (*note: as well as SCIs*).

All protected areas in the records of the Ministry of the Environment of the Slovak Republic.

## 6 Institutional mandate

### 6.1 Legal acts and other agreements

Protected areas (definitions, conditions for protection, designation, etc.) are regulated by the Act No. 543/2002 Coll. on Nature and Landscape Protection, as amended. The Government of the Slovak Republic declares protected areas by its regulation except for the municipal protected

areas which are declared by the municipalities and for the private protected areas which are declared by the competent district office.

Data on protected areas are recorded in the State Inventory of Specially Protected Parts of Nature and Landscape (§ 51 of the cited Act), management of which was entrusted by the Ministry of Environment of the Slovak Republic to the Slovak Museum of Nature Protection and Speleology (<http://www.smopaj.sk/sk/statny> - list).

*Note: In addition to the national network of protected areas, there are sites of the European network Natura 2000 (consisting from SPAs and SCIs) and areas of international importance designated in Slovakia according to regulations of EU and international conventions, agreements and programs in the field of nature and landscape protection. These areas overlap in a large extent with the national network of protected areas and are not included in the overviews of the Statistical Office of the Slovak Republic (except for SPAs).*

## 6.2 Data sharing

Information on protected areas are also provided in annual reports in the State of the environment report of the Slovak Republic and are published on the website of the State Nature Conservancy of the Slovak Republic - List of protected areas (<http://www.sopsr.sk/web/?cl=114>).

Nationally protected areas are also reported annually (by the end of March) at the European level - in the Common database for designated areas (CDDA): <https://rod.eionet.europa.eu/obligations/32>.
