As to the data published according to certain classifications (for example Statistical Classification of Economic Activities, Standard International Trade Classification, etc.) the names of indicators in English do not always correspond to literal names in Slovak language, but they are given according to the international classification, or an abbreviation is used.

The names of the countries are abbreviated, not always in official version.

Differences in sums and ratios result from rounding the data. Unless explicitly stated, the published data are definitive.
